LINCOLNS INN SIGNAGE POLICY

Version 1.0

1.0 PURPOSE

1.1 This policy has been developed to ensure a consistent approach to signage across the Inn that is sympathetic to the buildings and their surroundings.

2.0 DESIGN

- 2.1 Style: Black or red lettering on white or cream wooden board.
- 2.2 Location: Within the demise or on the internal side walls of the entrance to the building within which Chambers are located and not on the outside wall of the building without the express consent of the Estates Committee.

2.3 Lighting:

- Top lighting only
- No back lighting
- No harsh white lighting
- In each case unless otherwise expressly agreed and recorded in writing by the Estates Committee.

3.0 CONSENT

- 3.1 Listed Building consent may be required from the London Borough of Camden for signboards that affect the character of the building.
- 3.2 The set of Chambers would be the applicant within the demise; the Inn outside the demise.
- 3.3 The Inn will not support or make an application which does not fall within the Design parameters set out unless exceptional circumstances apply.

4.0 REASON

- 4.1 A survey of the nameboards within the 4 Inns shows a uniformity of traditional designs of such boards. These reflect and form part of the traditional character of the buildings upon which they are located. Recent developments in Lincoln's Inn, with or without listed building or the Inn's consent, reflect a departure from character of the signs and an introduction of harsh lighting.
- 4.2 The Estates Committee has resolved to maintain the traditional character of the buildings within the Inn and of the nameboards attached to sets of Chambers.




